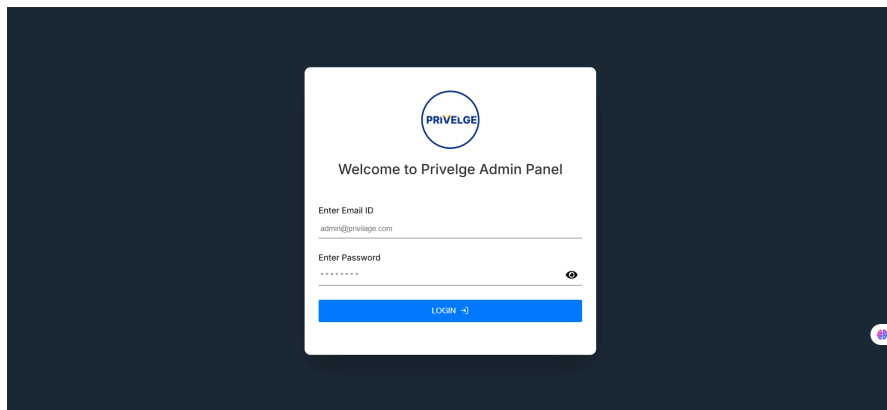


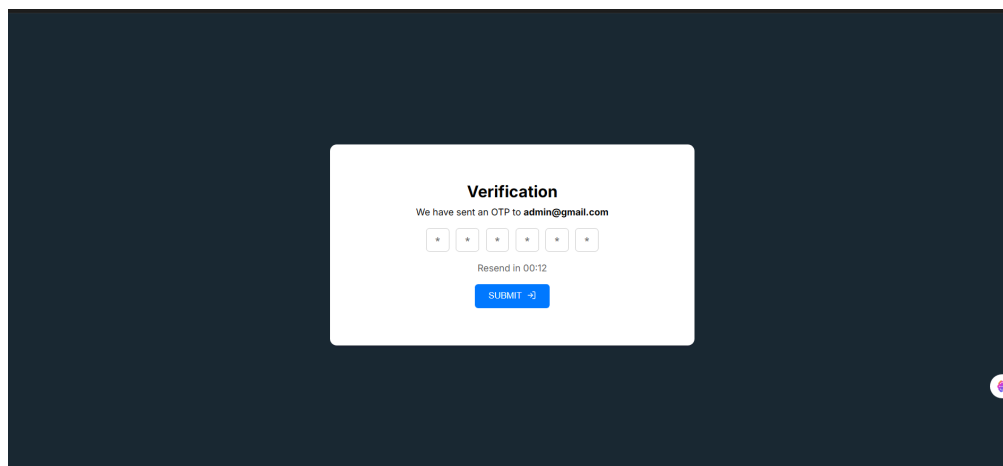

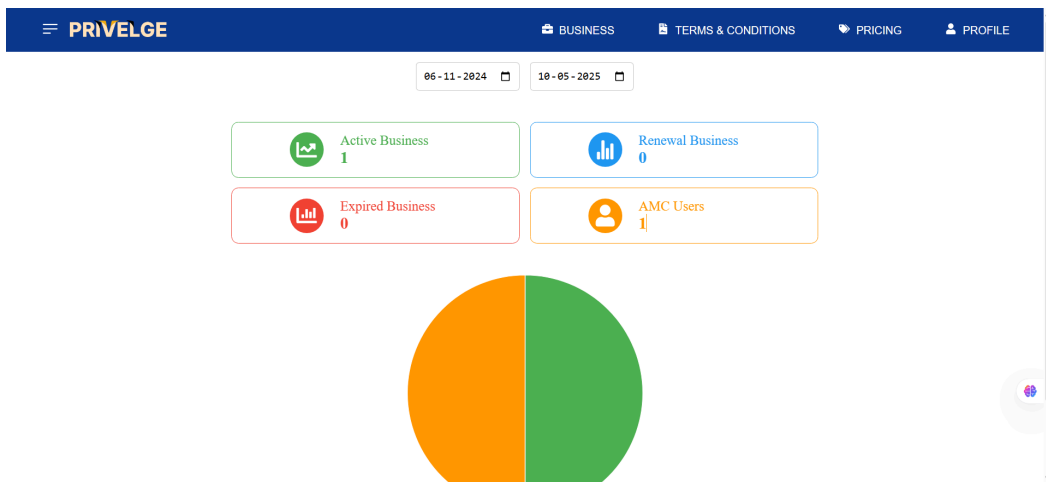
1.Login page of admin panel
